I am not a partner in any partnership I have never been adjudged bankrupt in any jurisdiction.
- I have never been a party to a scheme of arrangement or made any other form of composition with creditors.
- There are no unsatisfied judgments outstanding against me.
- No corporation has been put into compulsory liquidation or has had an administrator or other receiver appointed during the period when I was one of its directors or alternative directors. No partnership has been put into compulsory liquidation or has been sequestrated during the period when I was one of its partners.
- I have never, and no corporation of which I have been a director, shadow director or alternate director, been convicted in any jurisdiction of any criminal offence or an offence under legislation relating to companies. I have no spent convictions in any jurisdiction of any criminal offence or an offence under legislation relating to companies.
