

# Statutory Declaration & Undertaking

BKM Management Limited is a diversified company with investments in Australia and Asia. Its subsidiaries and associated companies are Scene Model Management Pty Ltd and IGC Asia Pte Ltd. I became a non-executive director of BKM Management Limited on 8 February 2002.

I am not the director or alternate director of any other corporation which is publicly listed or traded. I am not a partner in any partnership.
3. I have never been adjudged bankrupt in any jurisdiction.
4. I have never been a party to a scheme of arrangement or made any other form of composition with any creditors.
5. There are no unsatisfied judgments outstanding against me.
6. No corporation has been put into compulsory liquidation or has had an administrator or other receiver appointed during the period when I was one of its directors or alternative directors. No partnership has been put into compulsory liquidation or has been sequestrated during the period when I was one of its partners.


I hereby undertake that in the exercise of my powers and duties as a director, I shall:
